The names shown are as they appear in the Tax Duplicate and do not necessarily mean that the parties are the present owners of the property. Following the tax sale, the property continues to be assessed in the name of the owner. The reason for this is that a tax sale certificate does not give the purchaser thereof title to the land and does not divest the tax delinquent owner of this title. The tax certificate merely gives the purchaser of the certificate an interest in the property and the right to foreclose pursuant to established statutes. SAID LANDS to be sold in fee to such persons that will purchase the same subject to redemption of the same at the lowest rate of interest but in no case in excess of eighteen per cent per annum. This payment for sale shall be made before the conclusion of the sale, or the property will be resold. PAYMENT MUST BE MADE IN FULL BY CERTIFIED CHECK OR CASH. (Chapter 237, P.L. 1918). No letters of credit or

wire transfers will be accepted. Any parcel of real property for which there shall be no purchaser will be struck off and sold to the municipality in fee for redemption of not more than eighteen per cent per annum.

The Tax Sale is made under the provisions of an Act of Legislature entitled "AN ACT" concerning unpaid taxes, special assessments, water, sewer, or municipal charges on real property and providing the collection thereof by the creation and enforcement of liens, thereon and any Supplemental or Amendments thereon.

Industrial Properties may be subject to the Spill Compensation and Control Act (NJSA 58:10-23.11 et seq.), the Water Pollution Control Act (NJSA 13:1K-6 et seq.) or the Environmental Clean Up Responsibility Act. In addition, the municipality is precluded from issuing a tax sale certificate to any prospective purchaser who is or may be in any way connected to the prior owner or operator of the site.

Parcels are to be sold subject to rollback taxes under the Farmland Assessment Act of 1964, improvement assessment installments not yet due and any omitted or added assessments for improvement as provided in NJSA 54:1-63.2 and 54:4-63.3.1.

At any time during regular office hours, BEFORE November 15, 2018, the undersigned will accept payment of the amount due on any property with interest and fees incurred up to the date of payment PLUS all interest due on any subsequent delinquencies that are not included on this list. PAYMENT MUST BE MADE IN FULL BY CERTIFIED CHECK, MONEY ORDER, OR CASH.
